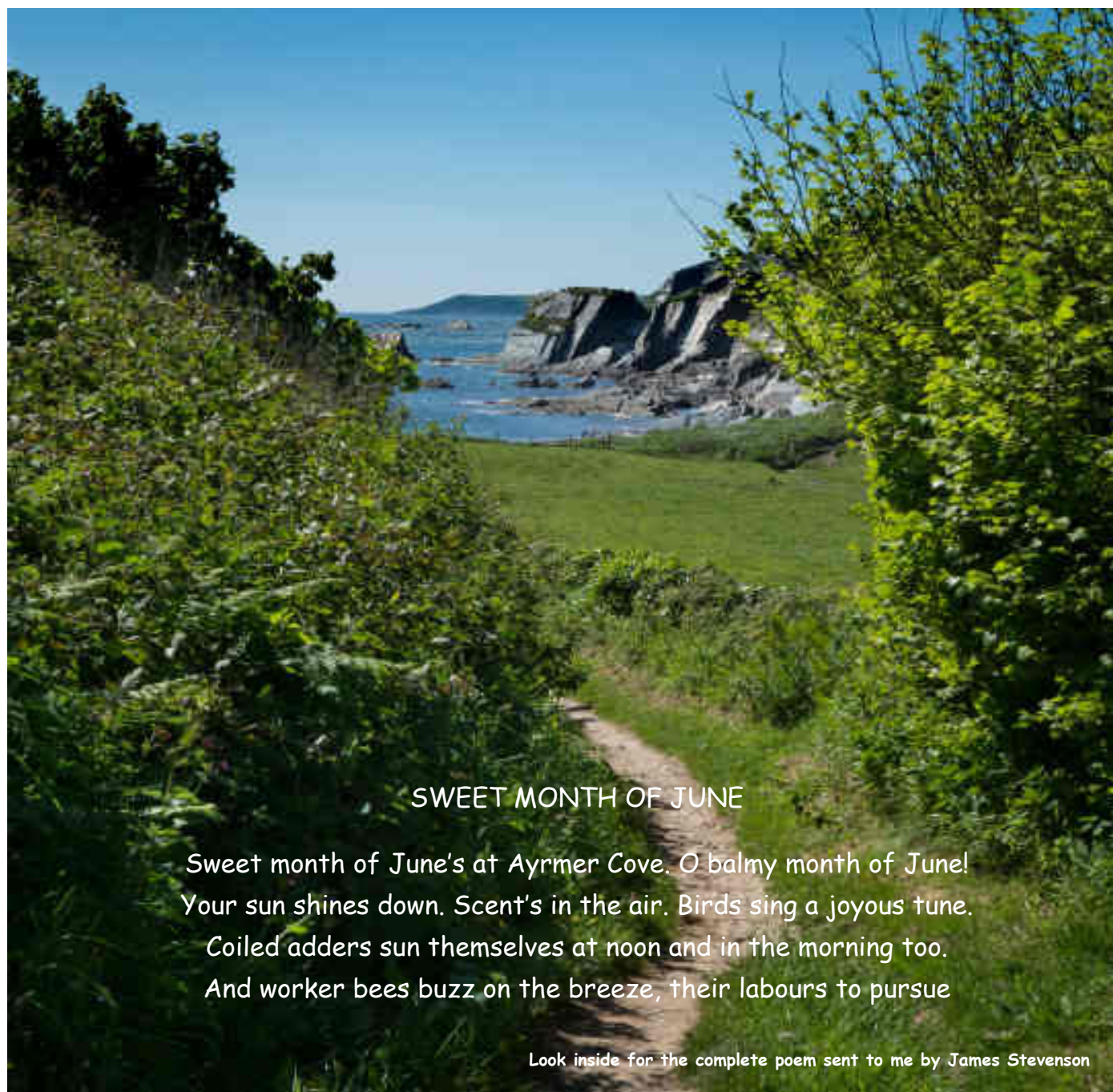

ALL CHANGE?

The five churches in the Modbury Mission Community face change with the retirement of Neil Barker. Who will be appointed? What will he/she be like? What new ideas will he/she have? What will change?

There is some truth in the suggestion that when a vicar retires, half the congregation want his successor to be a clone of his predecessor ("such a lovely man") and half want someone completely different who will do all the things his predecessor failed to do! There have always been opposing views about change, and "new-fangled" appears in the Book of Common Prayer, as the following extract shows

"Whereas in this our time, the minds of men are so diverse, that some think it a great matter of conscience to depart from a piece of the least of their Ceremonies, they be so addicted to their old customs; and again on the other side, some be so new-fangled, that they would innovate all things, and so despise the old, that nothing can like them, but that is new: it was thought expedient, not so much as to have respect how to please and satisfy either of these parties, as how to please God, and profit them both."

These tensions are still with us 400 years later, with some hankering after the "old" services in church and others wanting to ditch liturgy altogether. We all have our preferences, and there's nothing wrong with that. But spiritual maturity means being willing to worship on occasion in an "alien" style which others value.

The Bible reminds us that "Jesus Christ is the same, yesterday, and today and for ever". He is the Saviour for all time, whose promises are constant and true. The Christian gospel is an unchanging one. But it is not a fossilised, dead message; we proclaim it in ways which reach people of every kind.

So let's profit from each other's preferences, look for ways to proclaim Jesus Christ and seek above all to please and glorify God. And during this time with no Rector, let's use the prayer in the Parish Profile:

Almighty God, you know all our needs. Look graciously at this time on the people of this benefice. Send to us as Rector a faithful pastor, someone after your own heart, that, by your blessing, many may be brought to the joys of your eternal kingdom in Jesus Christ our Lord. Amen.

All Hallows Annual Parish Meeting & The Annual Parochial Church Meeting

The Annual Parish Meeting and the Annual Parochial Church Meetings were held on Wednesday 29th March. Judy Bull and myself were elected to continue as Churchwardens and were subsequently "sworn in" at the Benefice Service by our Rural Dean the reverend Jackie Taylor.

Ron Williams agreed to continue as Treasurer and was thanked for his past years duties along with Richard Baker who examined the accounts put to the meeting. It is with grateful thanks that Alison Vincent has continued to be our Secretary and the existing members agreed to continue there valued work on the Parochial Church Council.

Our Team Rector, Neil Barker, who retired at Easter was thanked for his leadership and support over the past 12 years. Neil has been greatly appreciated and has led to good fellowship within the Church and village and will be greatly missed. A full list of All Hallows Officers is on the church porch notice board.

Neil's Successor

The initial closing date for applications for the post of the Modbury Benefice Team Rector was the 2nd May. Bishop Nick has considered the applications and wishes to advertise the post again, keeping all the present candidates in the frame for the time being. This will allow for the possibility of a larger pool of applicants from which to shortlist for interview. He feels that this will offer the best chance of discerning a priest with the qualities and experience needed to answer a call to the appointment as our Rector.

The earliest revised interview date when the bishop and patrons are free is Thursday 20th July, and this means that the vacancy will not be filled until the end of October at the earliest. The position is therefore being re-advertised in the Church Times in early June.

The Bishop and patrons are disappointed that they will not be able to interview candidates as originally planned in May, but their priority is that the right person is appointed as Rector to the Mission Community and its five parishes. Please pray for a successful outcome,

Ringmore Neighbourhood Plan

A Neighbourhood Plan is the official way in which all members of the Parish of Ringmore can have their say on how the parish should develop over the next 5 to 20 years. There will be several parish wide consultations during the course of the process during the next 18 months or more.

The Parish Council confirmed at their meeting 16th May, their earlier decision to combine with the Ringmore Residents Association and go forward with a Neighbourhood Plan for the village. A registration form has been submitted to SHDC and we have received from them an acknowledgement and a Parish Map, which they would like us to use to designate the area under review.

An entirely independent and representative Steering Committee will be formed in the next few days and they will first need to write Terms of Reference which in turn need to be confirmed by the Parish Council at their meeting on June 13th.

Following that, the Steering Committee will consider an agenda and timetable for the initial steps to be taken this year. The whole process will take in excess of 18 months and there will be detailed consultation with the Parish via a questionnaire, exhibition or meeting from time to time.

The final document, when agreed locally will go to SHDC and then to a Government Inspector before being put to a Parish referendum for acceptance. The plan will then be a legal document.

The Steering Committee will report monthly to the Parish Council on progress and will also publish an update in the Newsletter.

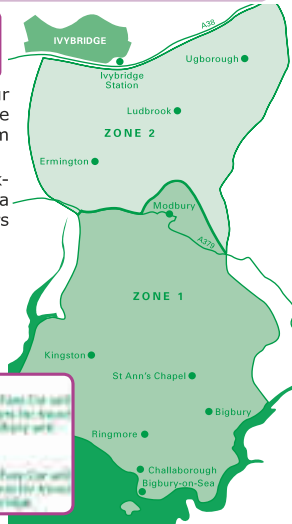

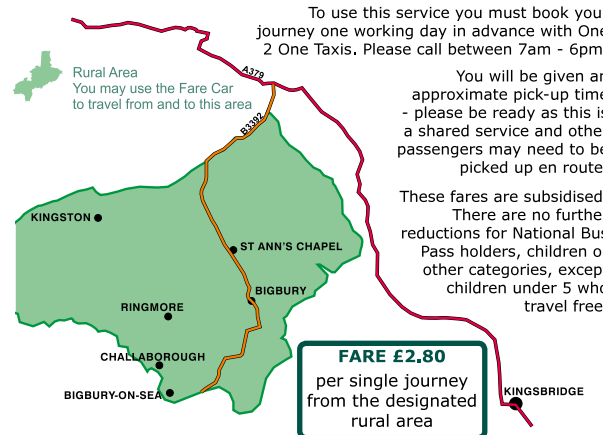

UK threat level raised to 'critical'

Deputy Chief Constable James Vaughan said: "As part of the ongoing investigations into the terrorist incident in Manchester on Monday night; the Prime Minister has announced that the independent Joint Terrorism Analysis Centre (JTAC) have raised the UK threat level from 'severe' to 'critical'.

As a result of this decision Operation Temperer will now be activated, alongside other established and tested plans, meaning that military personnel may now be deployed onto the streets under police command and control. Locations for deployment are agreed at a national level and, at this stage, there are no plans for deployment in Devon, Cornwall and the Isles of Scilly.

"Although we have no information to suggest any specific additional risk to Devon, Cornwall or the Isles of Scilly, we would urge the public to keep alert and not alarmed, and to support us in keeping our region safe by keeping an eye out for anything that seems out of place, unusual or doesn't seem to fit with day to day life.

"If anyone sees anything suspicious that they believe may be related to terrorism, they can report this to the Anti-Terrorist Hotline on 0800 789321 or call 999.

"It is important to stress that Operation Temperer and the raising of the threat level are both nationally agreed and affect the whole country, they are not specific to Devon and Cornwall. We will continue to work with our police and security colleagues across the country, as well as with the military and our local partners, to do all we can to keep the public safe."

Action Fraud has received the first reports of Tech-Support scammers claiming to be from Microsoft who are taking advantage of the global WannaCry ransomware attack.

One victim fell for the scam after calling a 'help' number advertised on a pop up window. The window which wouldn't close said the victim had been affected by WannaCry Ransomware.

The victim granted the fraudsters remote access to their PC after being convinced there wasn't sufficient anti-virus protection. The fraudsters then installed Windows Malicious Software Removal Tool, which is actually free and took £320 as payment.

It is important to remember that Microsoft's error and warning messages on your PC will never include a phone number.

Additionally Microsoft will never proactively reach out to you to provide unsolicited PC or technical support. Any communication they have with you must be initiated by you.

How to protect yourself

Don't call numbers from pop-up messages.

Never allow remote access to your computer.

Always be wary of unsolicited calls. If you're unsure of a caller's identity, hang up.

Never divulge passwords or pin numbers.

Microsoft or someone on their behalf will never call you.

If you believe you have already been a victim

Get your computer checked for any additional programmes or software that may have been installed.

Contact your bank to stop any further payments being taken.

72/17 OPEN SESSION

Richard Baker (RB) representing the Ringmore Residents' Association (RRA) spoke about the RRA which now had 50 plus members. The RRA supported the Chairman's comments expressed at the last meeting on parish council minutes and also supported the parish council's objection to the proposed new road development at St Ann's Chapel. The RRA was grateful to the parish council for organizing the open meeting on 18 April at which a number of people had expressed their views on the planning application to develop land south of Westbury (see minute 73/17 below). RB then presented his analysis of the views expressed at that meeting.

73/17 0669/17/OPA SX 653 459 LAND SOUTH OF WESTBURY RINGMORE, TQ7 4HN

73.1 Introduction

JW explained that following the open meeting held on 18 April this meeting had been called to allow councillors to discuss and then make a decision on the parish council's view on the planning application to build houses on the field south of Westbury. JW reminded members of the public present that the open session had now closed and they were welcome to listen to the discussion but under the rules governing council meetings they were not permitted to interrupt or comment.

73.2 Presentation by David Vincent (DV)

DV introduced a Power Point presentation to the meeting (copy on file). His presentation was an analysis of the views expressed at the open meeting and concluded with his personal recommendation to the council of the application under discussion.

That view is as follows:-

That the Parish Council recommends approval of the planning proposal with the following caveats:-

- The number of executive properties is reduced to three or four maximum
- That the affordable homes are protected by a section 106 agreement (*see explanation below*) in the plans and be provided under a local allocation policy to the benefit of residents of Ringmore, Bigbury and Kingston

73.3 Discussion

The Chair then opened the discussion to all councillors and suggested that the two elements of the application: affordable housing and larger open market executive style homes be considered separately.

73.4 Affordable Housing

Councillors were generally in favour of affordable housing being developed in the parish provided that the number of houses stated in the application (five) was actually built as affordable and offered to a housing association so that they would be occupied by local people. JD felt that there was a need for affordable homes for workers. AK was also in favour provided that the developer was legally bound to build such homes in association with a housing association. It was felt that a Section 106 agreement (*S.106 of the Town and Country Planning Act 1990 – see explanation below*) would be needed.

73.5 Five, 5 bedroom open-market houses

The application included five larger houses to be limited to a height of one and half rather than a full two storeys. Councillors felt that this would be too many large houses for Ringmore and that there was a danger that local demand would not be sufficient and therefore these would inevitably become 2nd homes, which it was clear all parishioners wished to discourage. Councillors were in general agreement that the limit of one and a half stories was imperative and that the number of houses should be reduced from five to three or four houses maximum with the development of these houses reflecting the changes in population structure as laid out in the LDP 3.101-3.102.

73.6 Further Development

Councillors were also concerned that potentially a developer could extend the new development into undeveloped parts of the site to the west of the proposed building area and that this must be discouraged.

The councillors agreed that approval to support the outline planning application was subject to the landowner providing firm assurance that the areas marked light green on the site development map could be protected from future development by a deed of covenant to existing adjacent properties

Addition to the Minutes held on 25th April Protection of the undeveloped area

Both JW and DV subsequently met with Mrs. A Lambell (on 6th May) to discuss the protection of the area within the field (highlighted in the attached document plan: 0669/17/opa Ringmore Parish Council Covenanted Area)

Mrs. Lambell advised that Mr. R Boyt (agent for Mrs. Lambell) has submitted an amended map to SHDC showing the area of the field to the west of the planned development (see the area in red highlights on the attached document) as now being deemed a non-development area and that this will be covenanted as such.

During the meeting Mrs. Lambell confirmed that this area is now a 'no-build' area and will be covenanted as such, following outline

approval of the plans, with the owners of the surrounding properties adjacent to the site. This assurance was accepted by JW and DV in good faith.

74/17 RESOLUTION

The Chair drew the discussion to a close and asked councillors how they wished to vote on the matter, either by a show of hands or by ballot. Councillors were happy to a show of hands.

RESOLUTION Ringmore Parish Council (RPC) recommends approval of the planning proposal with the following caveats:-

- The total number of open market houses should be reduced from five to three or four maximum with the development /design, reflecting the changes in population structure/housing needs as laid out in the Local Development Framework 3.101-3.102.
- The proposed affordable homes are protected by a Section 106 agreement in the plans and be provided under a local allocation policy to the benefit of residents of Ringmore, Bigbury and Kingston
- Ringmore Parish Council receives a firm assurance that the current owner of the site will:
 - provide a 'no build' covenant to each of the properties adjacent to the area of the field as shaded in red on covenant plan '0669/17/opa Ringmore Parish Council Covenant' (attached)
 - This covenant to be provided prior to any part of the field being sold, developed, or transferred by any means.(see section 73.7)
- As far as legally possible the application takes account of the existing Ringmore Parish Plan 2008 to impose local occupancy ties on the houses. The development overall be required to follow characteristics of the Ringmore settlement

The application under consideration is taken by SHDC as the qualifying number of houses in the Joint Local Plan and forthcoming Ringmore Neighbourhood Plan this development represents the total number of new houses that Ringmore can be expected to absorb over the foreseeable future and that any further applications will be vigorously resisted.

BH would like to arrange in Ringmore surgeries to meet parishioners to discuss concerns or issues.

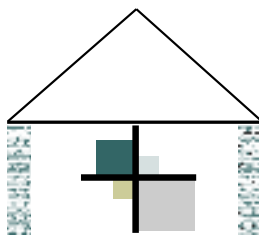
