## 2024.151 Highways

A recent 'Road Closure Notice' for scaffolding to be erected for the installation of solar panels was discussed and MC explained, following correspondence from DCC, that contractors were required to satisfy DCC that their proposals met statutory requirements and that should road closure become necessary

Councillors understand the ultimately responsibility for that lies with DCC as the Highways Closure Notice issuing authority. This needs to be confirmed by RG.

# 2024.153 Setting Parish Precept 2025/2026

SHDC has received and acknowledged RPC's precept request for 2026 2025, with the first half year's payment due in April.

# 2024.154 Movement of funds into a higher rate deposit account.

The proposal to move £8,000 into a higher rate Notice account has had to be reproposed to approve a higher amount of £10,000, which is the minimum amount acceptable. MC proposed movement of £10,000 into a Lloyds Bank 95 day account, JR seconded and Cllrs agreed unanimously. **IB to action** 

# 2024 155 Summary of Parish and WI marquee repairs.

The fabric of the Parish marquee is repairable at a likely cost of £250 and quotes are being obtained and an order of new poles from the original supplier is in hand.

# 2024.156 Challaborough

Outstanding issues to be discussed will be deferred to the March meeting. In the meantime the signage for yellow lining in Challaborough is being resolved by DCC Highways officer.

## 2024.157 Environmental matters:

A 'polite notice' will be delivered to residents to remind them of their responsibility for maintenance of trees, hedges and verges etc which abut footpaths and roads.

## 2024.158 To receive Parish Paths Partnership update

DCC's new footpaths officer has now established contact with HK and RPC and following a walkaround with their field officer DCC has agreed to deal with immediate maintenance of footpaths F1 & F13. No others have been identified as needing immediate attention.

# 2024.159 To receive National Trust update

The NT has not removed the dolphin washed ashore recently which remains as a health hazard. SHDC will be contacted for its advice and action in arranging for its removal. **IB to action** 

The triennial lease on the3 land upon which the Parish's storage container has been formally renewed (for a further 3 years).

# 2024.160 SHDC Grants for Business and Parish Councils

Locality budget grant funds have been received for the re-equipping of lighting in the Parish Rooms.

## 2024.161 Fibre optic installation into the parish

Alternative provision is being explored, now that the Ringmore has been excluded from the Connecting Devon and Somerset programme, due to lack of funds.

# 2024.162 New Councillor

SHDC has confirmed that a public election for a new Councillors is not necessary, therefore co-option to RPC will be possible if a candidate steps forward.
