MINUTES

Present: Cllr. Michael Campbell Chairman, (MC),), Cllr. H. Kent-Woolsey (HK) Cllr C. Eddy (CE), Cllr. John Reynolds (JR), Cllr. A. King (AK), Ian Bramble (IB) (Clerk). H. Hinkley (HH) Chair Parish Events Sub Committee, DCC R. Gilbert (RG), SHDC B. Taylor (BT),4 members of the public (MsP) attended.

A Challaborough resident spoke about the yellow line signage still needed in the village and that the mounting post for the previous signs had been cut down. IB will chase DCC for action on this.

County Councillor Updates:

RG reminded the meeting that this would be his last as a Councillor after 20 years of service first as a District Councillor and then as County Councillor.

RG advised that DCC has now produced for submission to government 5 options for consideration for a single tier authority, each with a population of between 300,000 and 500,000. The options include a Plymouth centred authority; an authority centred on Exeter and a 3rd centred on Torbay. The government decision is due in November, for all new authorities to be functioning by the end of 2028. All County and District Councils will be dissolved and elections for the new authority will take place, in Devon's case probably in 2027. An overlap period may be allowed, to facilitate a smooth transition.

On behalf of the Parish, The Chairman thanked RG for his support and work for Ringmore and wished RG well for his retirement.

District Councillor Updates:

BT reported that he had attended a meeting at Holywell Meadows to deal with 'snags' with the new builds; that the road and been adopted by DCC and that its surfacing could now be completed. Also, that the 3 Open Market houses had been acquired by SHDC, made possible by a government grant of £300,000 and would be let at affordable homes rates to those who lived locally or had strong local connections.

Although not in the Parish BT advised that the refuse bins at Sedgewell Slipway would be retained with collections three times a week and a financial agreement with RPC Ltd had been reached to maintain a bottle bank in the Bigbury on Sea car park.

2024 169 Summary of Parish and WI marquee repairs.

Lloyds Bank Interest:- February 2025

HH reported on progress for the 2025 August Bank Holiday event with costs at similar levels to last year's event. Support has been given by stallholders from last year, but including the Bank Holiday Sunday is being reconsidered.

2024.170 Challaborough

Signage for yellow lining in Challaborough is being resolved by DCC Highways
Officer and IB will chase for this to be completed.

IB to Action

2024.171 Environmental matters:

Maintenance of trees, hedges and verges is progressing, with only a few verges to now clear. A road sweeper will then be brought in for further tidying up work.

2024.172 To receive Parish Paths Partnership update

DCC's new footpaths officer has now established firmer contact with HK and RPC and that sits alongside the already strong contact with DCC's local officer.

2024.173 To receive National Trust update

The NT has not removed the dolphin washed ashore recently which remains as a health hazard. SHDC advise that it is the landowner's responsibility to move it will be contacted but also that the Natural History Museum may be interested in taking it to establish the cause of death. The NT would prefer to leave it to be washed back out to sea for nature to then take its course but Cllrs thought that that was now unlikely to happen and HK will re approach the NT.

HK to Action

2024.174 SHDC Grants for Business and Parish Councils

BT's Locality budget grant funds have been received from SHDC for the reequipping of lighting in the Parish Rooms.

2024.175 Fibre optic installation into the parish

Alternative provision is being explored with Airband to be contacted now that the Ringmore has been excluded from the Connecting Devon and Somerset programme, due to lack of funds.

2024.176 New Councillor

A new Councillor is still being sought to bring RPC up to its full strength of seven.
