

Ringmore Parish Council (RPC) Meeting

Tuesday, 20th January, 2026 at 7.00 pm in the WI Hall

MINUTES

Present: Cllr. M. Campbell, Chairman (MC), Cllr. C. Eddy (CE), Cllr. M. Hyde (MH), Cllr. A. King (AK), Cllr. H. Kent Woolsey (HK), Cllr. M. Findlay (MF), Cllr. M. Wood (MW),
DCC. L. Wainwright (LW), SHDC. Cllr. B. Taylor, Ian Bramble (IB) (Clerk) and 2 other members of the public (MsP) attended.

Members of the public were welcomed and invited to speak in 'Open Session'

County Councillors Update

LW presented her December report and advised that in the light of the recent gas outage in Kingsbridge, Marlborough and Salcombe, DCC's Emergency Plan will be updated and a meeting in Modbury Village Hall at 10:00pm on March 6th has been arranged to discuss and that templates for PC Emergency Plans are available from the Devon Communities Together website.

LW reminded Cllrs. of her visit with DCC Highways officer Adam Keay on Feb. 5th and meeting with Cllrs to establish a priority list of DCC

Parish road repairs and explained there is a backlog of £180m of road repairs in Devon but with a budget of only £100m allocated and that the lack of Highways funding from central government this meant;

- that this backlog was unlikely to be cleared
- that this work is contracted out until 2028
- it is known that the repair procedures adopted by the contractor are not fit for purpose but apparently cannot be changed within the contract term
- that this situation and more expensive damage to motor vehicles will have to be accepted

Cllrs. reacted to this with well-informed anger and argued that much fault lay with DCC's own inefficiencies and poor oversight, absence of quality control with no accountability for the work done by its contractor, along with criticism of its poor overall selection of spending priorities, while so much work is needed to maintain necessary, vital environmental infrastructure.

A member of the public voiced criticism, with examples given, of the absence of quality control of work done and poor management and, e.g. the inefficiency of filling one pothole but ignoring all others in its immediate vicinity, because the crew were 'only allowed to repair that one reported hole'. DCC was also criticised for being the only authority in the country to precisely define the dimensions of a pothole for which it will authorise repair.

LW was also asked where the extra government funding for pothole repairs was spent and if had been added in its entirety to its pre-existing highways budget and

why money and resources had been allocated to less urgent priorities, e.g. removing flags from street lamps.

That almost an hour was spent on this single issue indicates the strength of feeling expressed to LW by Cllrs and MsP.

District Councillor Update:

BT confirmed that both DCC and SHDC will be raising Council Tax for 20226 27 by the maximum amounts permitted without calling for a referendum and that SHDC off street parking charges will be raised by 4%. BT also updated Cllrs on progress on pressing Planning Enforcement cases.

2025.115 Precept 2026-27 (to include funding for NHP 5 yr Review)

The 2026 27 Parish Precept was discussed with reference to the proposed budget including the following new items;

After discussion of all the above, the level of Parish reserves, and the fact that an increase in the precept would arise without cost to resident parishioners from an increase in Band D equivalent second homes in the Parish, that in the light of general increases in costs of living the precept should be limited to a rise of 5% over the 2025 26 level, from £61.58pa to £64.88pa

MC proposed this increase, AK seconded and Cllrs approved unanimously.
