Salcombe Division Meeting on Neighbourhood Area Committees

Our Future

Funding cuts (72%) by national government since 2011 have already led to severe reductions in the level of services which Devon County Council can now afford to deliver to our local communities.

Whichever boundary change model is adopted - the proposed Local Government Reorganisation will not restore the level of funding needed to adequately provide legally obliged services to our parish communities.

Improvements in services will not be guaranteed by LGR because the level of savings possible by amalgamating the District and County Council services under one Unitary Authority, are likely to be dwarfed by the existing huge funding gap caused by inadequate government grants to local authorities.

There will not be a referendum on whether we want Local Government Reorganisation. The **enforcement** of **LGR** is expected to be **April 2028**.

Parish councils need to focus on how they can optimise the outcomes of LGR for the communities they represent.

Early 2026 – The formal Government consultation on the proposals will begin.

July 2026 – The Government aims to announce which proposal to implement in Devon.

- 6. Should parish council representatives and clerks receive an **allowance and mileage claims** for their involvement in NACs?



How will local voices be heard?

Local Government Reorganisation

28th November 2025 – DCC and SHDC (and other competing bids) will submit their final proposals and their financial modelling justifications to Government for their proposed **Unitary Authority boundaries**.

29th November 2025 SALCOMBE DIVISION meeting on Neighbourhood Area Committees

Early 2026 – The formal **Government consultation** on the proposals will begin.

July 2026 – The Government aims to announce which proposal to **implement in Devon**.

Sept 2026 – Secondary legislation laid in Parliament to **allow the boundary changes** to happen.

The 'Wards' for each Unitary Councillor might be bigger than the current 'Divisions' served by your current County Councillors (i.e. 16 parishes in the Salcombe Division served by Cllr Louise Wainwright). There could be TWO Unitary Councillors for each new Unitary Ward.

Unitary Councillors will step forward and will be **seeking election** as your Unitary Councillor and could be knocking on your doors from Sept 2026 to May 2027.

May 2027 – Elections to the new Unitary Council take place

SHDC and DCC continue to operate in parallel.

SHDC elected Members who would normally have come to the end of their 4-year tenure in May 2026 will have to stay on for another year.

April 2028 – New Unitary authorities and Neighbourhood Area Committees go live.

DCC and SHDC and all District Councils in Devon cease to exist.

Can parishes influence decisions?

Neighbourhood Area Committees (NAC) are proposed as a new level of local government – rather like the current South Hams Highways and Traffic Order Committee – HATOC).

It could be composed of the

- locally elected Unitary Councillors,
 Representatives parish/town councils,
 - Health and Police services.

Parish and Town Councils should be lobbying to have their say now about how they want to be represented on the NAC (if they are set up).

It's unlikely in my view, that all parish councils will be represented on a NAC because this would make it unwieldy. If this is so, some level of **cooperation between parish & town councils** would be a good plan.

The purpose of a NAC is to address the highly likely alienation of parish and town councils from the decision-making Unitary Authority. Without a NAC how will the 'voice' of local people be heard when decisions are taken about local priorities for spending the already inadequate budget?

BLUEprint for Rivers

Thank you to those parish councillors who attended the **River Summit** (4th Oct) and participated in the Local Government breakout session.

This was an opportunity to express and interest in being part of a bid to the **Water Restoration Fund** in March 2026 for funding to assist ambitions of the parish councils to undertake any activity or host any event that could have an impact on water quality.

The BLUEprint steering group has ambitions to submit a bid to the Water Restoration Fund for £500,000 to £2 million. The project bid will cover three main stakeholder group projects - farmers, landowners and businesses, local government and community groups.

The three catchments involved are the

- River Gara & Slapton Ley,
- River Avon
- Salcombe Kingsbridge Estuary.

The proposed local government (parish and town councils) involvement would be through **Catchment Water Quality Groups** which link up parish councils within a river or estuary catchment to work together on water quality and engage in river-sensitive planning. This would involve:

- 1. Promoting the work of the BLUEprint for Rivers at the **Annual Parish Meetings.**
- Receiving reports from the River Ranger funded by the BLUEprint project covering local projects aimed at restoring water quality
- 3. Deciding if the parish council needs to focus on any matters arising from the River Rangers Reports, as an **agenda item**
- 4. Sharing the River Rangers reports though local parish communication channels website, social media etc.

Highway Matters

Parish Priorities

I am grateful to our Neighbourhood
Highways Officer, Adam Keay, parish
councillors and clerks who have joined the
site meetings to bring local priorities to the
attention of the Highways Team. We have
now had meetings with Aveton Gifford,
Modbury, Churchstow, Loddiswell,
Kingston, Malborough, Salcombe and
Thurlestone. Meetings in November will
cover South Huish, South Milton.

All parish councils in the Salcombe Division have been invited to discuss and prioritise local highways matters as a **full agenda item** at their monthly meetings.

This enables our NHO to consider local priorities when allocating his annual budget. It also provides our parish councillors a greater insight into the financial and legal constraints within which we all have to work.

Together we are encouraging parishioners to first bring their concerns to their parish councils to ensure they are considered in the Parish Priorities.

Parish Lengthsmen

A couple of decades ago, when funding for Devon County Council was sufficient for its needs... there were 8 full time Lengthsmen in the South Hams with four vehicles.

These teams kept our drainage network working properly to keep the **water off our roads**. Keeping water off the roads reduces the damage and subsequent potholes that arise. Prevention is better than cure.

Most of this work was done with shovels and manpower. Silt along the road and in our gullies was removed by manual labour There are now two Lengthsmen, under the management of **Milestone Ltd** who serve the whole of Devon. That's about **1 or 2 man days per parish per year.**

Poor maintenance - higher remedy costs

This hugely significant reduction in manpower has meant that intensive maintenance programmes do not exist.

We now have to rely on more expensive mechanical equipment (gulley suckers and diggers) to clear the build up of silt in a drainage network which no longer benefits from regular clearing. We have been forced to implement a gulley-clearing programme which identifies high priority gulleys which are cleared every year and others that are only cleared every three years.

We rely on the public to **Report It** to the DCC maintenance teams if gullies or buddles need clearing. https://www.devon.gov.uk/roads-and-transport/report-a-problem/

On a report, an inspection will take place. If it meets certain criteria it will be pushed up the maintenance programme. This is not ideal. DCC cannot afford to do more. We could improve the feedback on the action taken after a defect has been reported.

Parishes funding local Lengthsman

In an attempt to redress the funding gap an improve local drainage, some parish councils are now funding more Lengthsman man-days themselves.

Buddle Management

Buddles are ditches which take water from our roads, through hedges to drain onto local farmers' fields. It remains the responsibility of farmers to keep the buddles clear on the other side of the hedge so that the roads are not flooded. In earlier times, the council would arrange to remove the silt which built up in the field. This no longer happens.

October Meetings

In addition to attending as many parish council meetings as possible this month, I also made time to contribute to the work of a number of outside bodies where DCC is represented.

Devon Farms Estate

In my capacity as **Vice Chair** of the **Devon Farms Estate Committee**, I have made several farm visits in October with the Audit Team to meet prospective tenants whilst they have been viewing DCC tenant farms where the tenancy is being renewed and to catch up with new farmers on some of our 'starter farms' to monitor their progress.

These are some of the farms I visited in October or are in the programme for November.

Further to these visits I will be attending meetings at Venture House in Exeter to discus end-of-tenancy protocols and also assisting in the interview panel for prospective new tenants for three days in December.

I also prepared briefing papers for information of the DFE Committee on:

- Integrated Pest Management of ticks in pasture using an entomopathogenic fungus - Metarhizium.
- Biological control of TB in badger runs and latrines using antagonistic microbes.

I contributed to the SDNL Committee deliberations at Follataon House this month on the core funding report from Roger English.

I contributed to the meeting held in Exeter for the D&S IFCA **Byelaw and Permitting Sub-Committee** meeting.

Emergency Planning

I contributed to a meeting at **Aveton Gifford** and Buckland tout Saints on Parish Emergency planning.

SHDC Energy Assembly

I was a delegate at the Energy Assembly organised by Sustainable South Hams and funded by SHDC.

Devon Energy Prospectus

Devon County Council, North Devon Council, North Devon Plus, Plymouth City Council, Torbay Council and Torridge District Council have jointly launched the **Devon Energy Prospectus**, setting out the region's bold ambitions and extensive investment opportunities in clean energy.

Councillor Julian Brazil, Vice Chair of the **Devon and Torbay Combined County Authority** (DTCCA) said:

"With the UK government targeting a rapid transition from fossil fuels to domestic clean energy, Devon is well-positioned to lead. The region offers one of the UK's strongest regional platforms for clean energy growth, combining a robust supply chain, strategic infrastructure, and world-class expertise to deliver at scale."

Councillor Ken James, Leader of Torridge District Council and member of the Devon and Torbay Combined County Authority (DTCCA) Board said:

"With an economy worth £31.5 billion and a population of over 1.2 million, Devon has the scale and capacity to deliver clean energy infrastructure at pace. We're working in partnership across the region to attract investment, create jobs, and strengthen energy security, bringing real benefits to our local communities through cleaner energy and sustainable investment."

The prospectus highlights Devon's leadership in floating offshore wind (FLOW), with the White Cross project in North Devon set to become the region's first FLOW development after recently receiving full planning consent. Work is expected to begin on the cable in 2027, and on the wind farm in 2028. The 100 MW project will power nearly 135,000 homes and serve as a catalyst for larger Celtic Sea developments.

Councillor David Thomas, Chair of the DTCCA, said:

"This prospectus shows the scale of opportunity for clean energy investment throughout Devon. With over **146 MW of operational onshore wind** and **billions of pounds of potential investment** in projects like Celtic Sea FLOW, we're ready to work with government, industry and investors to realise this potential."


Councillor Tudor Evans, Leader of Plymouth City Council, added:

Clean energy isn't just an environmental imperative – it's a massive opportunity to reshape our economy, spark innovation, and create high-quality jobs for the future. We're proud to be part of a bold, collaborative vision that puts our coastal strengths, engineering talent, and research excellence to work powering the UK's energy transition."

The Devon Energy Prospectus also outlines opportunities in **solar**, **green hydrogen**, **geothermal energy**, and **critical minerals**, supported by a growing clean energy **supply chain** and a skilled, **innovation ready workforce**.
